An organizational structure designed to serve regions and projects

Regions

Our structure of multi-expertise regions is designed to bring us as close as possible to our customers, and is tailored to take account of France's most recent regional restructuring plan - the NOTRe law. With more than 100 locations across 13 Regional Divisions throughout France, NGE works closely with the regions to support projects sponsored by public and private contracting authorities.

Major Projects

This department is dedicated to managing and delivering large-scale infrastructure projects, and is structured into three operations departments: major national projects, major multi-specialist projects & structures, and major fiber & energy projects.

International

The Group has adopted its French operating model for its international markets to take the multi-expertise concept to a new level outside France and to boost intra-Group synergies. With an existing presence in many countries through its rail infrastructure subsidiary TSO, international projects are handled by NGE Contracting and Générale Routière in Morocco.

INTERNATIONAL

Expansion in Mexico

To establish an even closer relationship with this market, NGE has a permanent presence in Mexico. This 220-person team has already been awarded 2 rail ballast undercutting contracts in 2018.

Crossrail in London

With delivery of the Plumstead maintenance depot, November 2018 marks the end of more than 5 years of work on the future Elizabeth Line, which is expected to carry up to 200 million passengers per year from 2019 onwards.

Morocco

Générale Routière, the Group's Moroccan subsidiary, has recently demonstrated the power of the multi-expertise model on its project to triple the rail link between Casablanca and Rabat: the coordinated pooling of expertise has enabled this company to successfully complete its first slide-in bridge project.

Additional contracts in Panama

Panama continues to place its trust in the Group, with its award of the contract to build Line 2 of the capital's subway system. The contract follows the successful completion of Line 1 and provision of its ongoing maintenance.

The Dakar TER regional express line in Senegal

150 people have been working on the project to construct the TER regional express line in Dakar since June 2018. When completed in summer 2019, the new line will link central Dakar to the new Blaise Diagne airport.



FRANCE

Flamanville EPR nuclear reactor

Having been awarded its third contract for the Flamanville EPR, with the construction of the building platforms needed for steam generator replacement operations, NGE now has a permanent presence on the nuclear power site, having previously installed infrastructures here, including the platforms required for the ultimate backup diesel generators.

Saint-Flour bypass

The 7-kilometer bypass to the north of the town via the RD926 will improve traffic flow considerably, at the same time as relieving congestion in Aurillac and Murat. The 100% NGE consortium began site work on this 22-month contract in February 2018 under the terms of a Public Private Partnership with NGE Concessions.

The Institut Mines Télécom

On the Paris-Saclay campus, construction work on the Institut Mines Télécom is progressing in leaps and bounds.

Grand Paris

The Line 11 worksites are running at full capacity. The first of the Group's 4 tunneling machines has begun tunnel boring operations for Line 15.

Tramway

NGE is carrying out the track and civil engineering works for the new tramway in Avignon. The Group is also building the future Caen tramway network at the same time. Both will be delivered and commissioned in 2019.

To ensure its ongoing development, NGE has succeeded in putting in place the necessary measures, anticipating new requirements and further improving its ability to identify new opportunities for growth.

Grand Paris Project

In 2018, NGE confirmed its status as a major force in underground operations with the award of a new contract as part of the Grand Paris infrastructure project: Line 14, which will link Orly airport to Lines 18 and 15 of the Paris Metro. It is also a member of the consortium awarded work package 1 on Line 16; the largest single work package of the entire Grand Paris Express project.

Benefiting from the French freeway regeneration plan

The Group's status as a leading force in freeway widening projects was confirmed in spring 2018 with the award of a contract to widen a 22-km section of the A13 between Dozulé and Pont-l'Evêque.

This major project (5 years of on-site work) will become a reality following the creation of the first semi-public partnership for a specific public project (Société d'Économie Mixte à Opération unique or SEMOP).

Confirming the Group's status as a leading force in fiber

With its March 2018 award of the fiber rollout contract for the department of Hérault, NGE Infranet confirms its status as a leading force in Superfast Broadband Infrastructure: 255,000 connections will be made in 286 districts between now and 2022, bringing the total order backlog for 2018 to €1 billion.

Acquisitions that support production

NGE Fondations came into existence in April 2018 following the merger of GTS with Dacquin. The new business is the third-largest general contractor for foundations in France, and expands the range of NGE services, at the same time as adding a new level of expertise.

Increased momentum for CSR

Conscious of the fact that its business has no long-term future without an active policy in place to reduce its environmental footprint and address sustainability issues across a broader spectrum, NGE has rolled out a number of initiatives that deliver on its commitments to corporate social responsibility.
