# NGE awarded two new contracts, positioning Egypt as its first rail country worldwide.

NGE continues its international expansion by securing two major contracts: the 112 km modernization of the Cairo-Beni Suef rail line and the 20 km extension of the LRT 10<sup>th</sup> of Ramadan to the New Capital. These two sustainable mobility infrastructure projects further strengthen NGE's position as a key player in Egypt's rail sector, following the 2023 award for the construction of 330 km of high-speed rail.

NGE is present in Egypt since 1981 through its subsidiary TSO, which actively contributed to the development of Egypt's main rail infrastructure. The Group's presence has grown stronger over the years, with more than 800 people now working there. The announcement of these two new contract awards coincides with the inauguration of NGE's new offices today in Cairo.

The Cairo-Beni Suef modernization project aims to enhance safety, operational efficiency, and reliability for both passengers and freight, thereby supporting Egypt's economic growth. This comprehensive renovation of 112 km of track includes the replacement of ballast, sleepers, rails and 357 turnouts. Given the heavy traffic on this line, all work will be conducted under strict interception operations, with five hours for the upgraded track and an hour and a half for the secondary track.

The second project is the phase 3 of the LRT 10<sup>th</sup> of Ramadan. This 20 km extension will offer an interconnection with the *Ain Sokhna – Marsa Matrouh* high-speed rail line, where TSO is carrying out the track works. The extension project is being undertaken in partnership with Orascom, already a partner of TSO on phases 1 and 2 of the LRT 10<sup>th</sup> of Ramadan, which runs from Adly Mansour station (Cairo) to the City of Arts and Culture station (New Capital).

These two newly awarded projects are carried out with our partner Orascom.

"We are proud to announce the signing of these strategic contracts, which demonstrate our commitment to improving rail infrastructure in Egypt. The NGE Group's strategy to develop low-carbon mobility infrastructure worldwide fully aligns with these projects. The two new contracts, along with the opening of our new offices in Cairo, where our team is based, confirms our key role in transforming Egypt's rail sector. The major projects successfully carried out here in Egypt over the past 40 years have established NGE as a trusted partner, contributing to the country's economic growth." In 2024, TSO achieved significant milestones in the railway sector in Egypt. This year's flagships projects include the successful completion of Phase 3 of Cairo Metro Line 3 and, the start of the track laying on the High-Speed Rail.
